

## INFORMATION ON THE PROCESSING OF VISITORS' PERSONAL DATA

Pursuant to the EU General Data Protection Regulation 2016/679 (the **GDPR**), the Greek Data Protection Law 4624/2019 and any other applicable Privacy Laws in Greece, Nexi Greece Processing Services Single Member S.A., acting as the Data Controller for the personal data of those persons who access Nexi Greece premises, provides the following information:

<b>Details of the Data Controller</b>	The Data Controller is Nexi Greece Processing Services Single Member S.A. (hereinafter, " <b>Nexi Greece</b> "), established and operating under the laws of Greece, registered in the General Commercial Registry (GEMI), with No 6276801000, registered seat in the Municipality of Dionysos (23rd km National Road Athens Lamia, Agios Stefanos, P.C. 14565 Attica-Greece) owned and controlled by Nexi S.p.A., with registered seat in Corso Sempione 55, 20149, Milan (Italy). <b>Categories of Personal Data processed</b>	Name, Surname, ID/Passport, Signature
<b>Processing purposes and modalities</b>	Personal data are processed to identify people only for purposes of corporate security and access control in Nexi Greece premises. Personal data, which are collected directly by the Data Subjects or obtained through video-recording instruments (CCTV), can be processed through the use of automated means to connect them according to variable categories depending on the different situations and needs or through manual means, and in any case, for reasons strictly related and limited to the aforementioned purposes, ensuring data protection and privacy.
<b>Legal basis of the processing</b>	The legal basis on which the processing of the collected data relies is the legitimate interest of Nexi Greece to guarantee the safety of persons (e.g. visitors, employees), protection and integrity of corporate assets, pursuant to the GDPR, the respective provisions of the Greek Data Protection Law and the guidelines of the Hellenic Data Protection Authority on video surveillance (CCTV).
<b>Recipients of Personal Data</b>	In addition to authorized internal resources entrusted by the Data Controller, for the execution of activities related to data processing of Visitors' personal data, Nexi Greece partners with external companies for: <ul style="list-style-type: none"><li>▪ Reception desk, administration and surveillance systems management;</li><li>▪ Maintenance of safety systems and access control.</li></ul> Those external resources that may have access to or process data shall act as "Data Processors" pursuant to the law and are contractually engaged with appropriate confidentiality obligations.
<b>Data transfer outside the EEA (European Economic Area)</b>	No personal data is disseminated nor is subject to international transfers.
<b>Data retention period</b>	Data are retained for a period not exceeding the time necessary for the fulfilment of the purposes for which they are collected. The following retention periods apply in Nexi Greece: <b>CCTV Retention Periods:</b> <ul style="list-style-type: none"><li>▪ 14 days for common areas</li><li>▪ 45 days for High Security Areas under PCI PIN requirements</li><li>▪ 90 days for High Security Areas under PCI Standards</li></ul> <b>Registration Log Book (Entrance):</b> 15 months (as per PCI Standards)
<b>Data Subjects' rights</b>	Data Subjects can exercise the rights pursuant to articles 15-22 of the GDPR, e.g. Access to personal data, Rectification, Erasure, Objection, Restriction, Portability of data. The exercise of these rights may be subject to certain restrictions provided for under the GDPR and articles 33-35 of the Greek Data Protection Law.
